THE SCHOOL ENROLLED 830 STUDENTS FOR THE YEAR OF WHICH 82 STUDENTS GRADUATED FROM THE CLASS OF 2015 AND 100% OF THOSE GRADUATING PURSUED A COLLEGE GRADUATION. ADMINISTRATION AND FACULTY PARTICIPATED IN SCHOOL-SUPPORTED PROFESSIONAL DEVELOPMENT PROGRAMS. A STRONG VOLUNTEER GROUP OF OVER 250 HELPED THE SCHOOL ACHIEVE ITS ANNUAL GIVING GOALS.
