Final comment. On the 990 regular it asks to explain if your assets are reduced considerably. In our case it is easy. Other than our basic operations, our projects run on grants. In this year we had some projects and partnerships that finished up after using grant money received the previous year, one project in which the grant came in after the fiscal year ended, and one project that after 4 years launched as their own 501c3 (BIG Success) and we handed over to them all of the money they had raised that they still had parked with us.
Our operational budget ran a surplus of about \$300 for the year, so while our assets were reduced by around 60% we are good.
