TO NONPROFIT PROGRAMS THAT MEET ONE OR MORE OF THE WI'S FOCUS AREAS EARLY CHILDHOOD DEVELOPMENT, EMPOWERING YOUNG WOMEN, AND FINANCIAL STABILITY YOUNG LEADERS SOCIETY THE YOUNG LEADERS SOCIETY
