Connecticut Legal Services provides civil legal assistance (representation and counseling) to help low-income individuals and families so that they may know and enforce their legal rights. We help our clients use the law to improve their lives and resolve significant legal issues involving various areas of civil law including domestic violence/family; homelessness/housing rights; government assistance programs; health care access; employment; special education; juvenile law; elder rights including nursing homes issues and consumer law issues; immigration; and disability law. During the 2014/2015 fiscal year, CLS advocates provided assistance to 3,275 low-income households consisting of 7,615 individuals, including 2,998 children. Advocates also worked on 2,123 active cases that were brought forward from the previous fiscal year. In addition, 216 outreach/ community legal education events were held throughout our service area, reaching over 4,500 individuals. Over 4,100 legal educational pamphlets were distributed at these events. Connecticut Legal Services received a total value of \$229,555 in donated services during the 2014/2015 fiscal year to support the work described above. No donated office equipment was received during the 2014/2015 fiscal year.
