The New Haven Free Public Library Foundation transferred direct support to the Library, enabling services and programs ranging from expanded collection purchases to children's summer reading programs. The Foundation is engaged in a major fundraising initiative to secure funds for the Library's primary funding priorities: purchase of a new Readmobile van, re-design and implementation of a new business engagement center, re-design and expansion of the Young Minds floor at the Main library and restoration of the Library's WPA murals. The Foundation raised temporary restricted support for these initiatives.
