Grantmaker's Description of How Grants are Used	Applications are sent to the seminaries and the Financial Aid Officer decides which students' needs are the greatest and gives out application instructions to students who access the forms on our website SIM gets applications back in mid-March along with any backup showing financial needs of the candidate and reference letters Each member of the SIM Scholarship Committee is given copies of the completed applications from an individual seminary, and scholarship needs of the seminarians are reviewed by them The Committee then meets as a whole and each member gives his or her recommendations for the consideration of the entire committee If a seminarian is awarded a scholarship, an award letter is issued to the student, with copies going to the Seminary, the sponsoring Diocese, and the sponsoring Parish Checks are cut and distributed either in person by Mr Thomas Moore, Executive Director, the Rev David Cobb, Chair of the Scholarship Committee (who is the Rector of Christ Episcopal Church in New Haven CT), clergy representatives who are SIM alums and live near a seminary (e g , Church Divinity School of the Pacific in Berkeley CA), or they are mailed directly to the student in October and February (one half of the grant each semester) Scholarship records are maintained by SIM for at least ten years
