Atlanta's Fox Theatre is a world-renowned concert and event venue like no other. Conceived as the headquarters for the Atlanta Shriner's organization in 1928, the building was designed to evoke the mystery and magic of the ancient Near East. Spanish palaces and Egyptian temples influenced the building's elaborate and intensely ornate design which features soaring domes, sweeping archways, stunning gold leaf, and sumptuous interior details including a vast cobalt "sky" with a sea of twinkling stars. The building was completed by movie mogul William Fox in 1929 and flourished as Atlanta's premiere movie palace until 1932, when the economic impact of the Great Depression forced Fox and the theatre into bankruptcy. The Atlanta icon was purchased at auction for a fraction of its original cost and remained in high demand for the next three decades, showing hundreds of acclaimed films and hosting live performances from legendary entertainers. Despite the Fox's success, landmark movie palaces had begun to fall out of favor in the 1960s as customers migrated to the suburbs. In 1974, the Fox Theatre closed its doors, and the stunning landmark, beloved for generations, was suddenly facing demolition. Confronted with the possibility of losing the iconic building, the residents of Atlanta sprang into action. They formed a non-profit called Atlanta Landmarks and launched the now-legendary "Save the Fox" campaign, which raised funds to save the building from demolition. Atlanta Landmarks (now called Fox Theatre, Inc.) continues to run the theatre today, making it one of an elite group of not-for-profit theatres in the country committed to making performance art accessible to everyone. Each year, the award-winning theatre hosts more than 250 shows and welcomes half a million visitors to experience the best in Broadway, concerts, ballet, comedy and film. In the past decade, the Fox has been widely recognized by industry leaders for excellence in arts and entertainment, preservation and arts education. It was nominated for Theatre of the Year by Billboard and Pollstar Magazines, and awarded the Outstanding Historic Theatre of the Year award in 2011 by the League of Historic American Theatres. The Fabulous Fox was most recently given the distinction by Rolling Stone Magazine as one of "The Best Big Rooms in America". For the past decade, The Fox Theatre has been consistently ranked in the top three theatres in North America for gross ticket sales, making it clear that this Atlanta icon will be making memories for generations to come.

The Fox Theatre Institute (FTI) is an award winning outreach program offering historic preservation and operations expertise, consultation and education to performing arts venues in Georgia and the region. Created by Atlanta's fabulous Fox Theatre - an iconic attraction widely applauded for being a catalyst for positive change in the community - FTI pays it forward, helping other cultural institutions renew, reinvigorate and restore artistic vitality in their respective communities. In keeping environmental and economic impact top of mind, FTI offers the financial assistance, restoration support, and operations mentoring needed to leverage scarce resources and stimulate local economies. FTI was founded in 2008 in response to a statewide need for assistance with the restoration and operation of Georgia's historic theatres. During its brief history, FTI has become an indispensable resource for historic theatres throughout the state, fulfilling the Fox Theatre's vision to share its experience in historic preservation and theatre operations with others. At a time when preservation and arts agencies are experiencing budget cutbacks, FTI is filling a community need by awarding grants and providing support to these community landmarks. In short, FTI is revitalizing Georgia's communities, one theatre at a time. As part of this outreach program and to help future generations understand the importance of such historical performing art venues such as the Fox Theatre, FTI has created the "Fox in a Box." An interactive school exhibit that focuses on how important events in the Fox Theatre's timeline intersect with key classroom lessons, from American history and the Civil Rights Movement to economics and the importance of communities. Elementary students are then challenged to think about how communities can come together to share an experience and to protect what's important to them.

THERE WAS NO APPRAISAL OBTAINED AT THAT TIME, HOWEVER IT DOES NOT SEEM UNREASONABLE THAT THIS AGREEMENT WAS ENTERED INTO AT ARMS LENGTH AND WAS FAIR MARKET VALUE AT THE TIME.
