OVER THE PAST 145 YEARS, THE FOUNDLING HAS EVOLVED FROM A RESPITE HOME FOR ABANDONED CHILDREN, TO A COMPREHENSIVE SPECTRUM OF COMMUNITY SERVICES IN SUPPORT OF OUR MISSION TO EMPOWER CHILDREN AND FAMILIES TO LIVE HEALTHY, INDEPENDENT, AND FULFILLING LIVES. OUR VISION IS A COMMUNITY WHERE EVERY PERSON, REGARDLESS OF BACKGROUND AND CIRCUMSTANCE, ENJOYS THE SAFE, STABLE, AND SUPPORTIVE RELATIONSHIPS NEEDED TO REACH HIS OR HER FULL POTENTIAL.
