WCS has set up a multi-stakeholder, transboundary inflative with the objective of working with partners to achieve the ecological restoration of bison across its range in North America. 2 The Queens Zoo has successfully bred critically endangered Puerto Rican crested toads (Peltophryne lemur) for reintroduction to their native Puerto Rico and Aquariums (AZA) zoos to boost the wild population. Puerto Rican crested toads are brown to yellow-brown in color and covered with warts and blackish spines. The tadpoles were sent to Puerto Rico where biologists from the Caribbean Ecological Services and the Puerto Rico. Department of Natural and Environmental Resources (PRDNER) introduced them to their low-lying rocky habitats. 3 The Central Park Zoo opened an exhibit for rescued grazzly bears. The exhibit opened as the new home for two adult female grazzles, Betty and Veronica, who were rescued in 1995 and brought to the Bronx Zoo.
