My Sisters' Place offers emergency residential services to victims of domestic violence and human trafficking and their dependent children, providing temporary housing and advocacy on their behalf. During the fiscal year ended June 30, 2015, the shelters provided 12,693 bednights to 78 adults and 109 children. Our 24-hour crisis hotline, where victims can receive emotional support, information, referrals, and access to shelter services, engaged with 3,123 callers during the fiscal year. Through creative art activities and therapeutic play, residential counselors create a safe environment for children housed in the shelters to express their feelings. The residential counselors conducted 8,974 individual

My Sisters' Place offers free non-residential supportive services to adult and child survivors of domestic violence and human trafficking. Non-residential services include individual and group counseling, advocacy, personalized safety planning, information, referrals, and therapeutic child care. Through a non-judgmental approach, we aim to honor client self-determination and create a safe space to help clients empower themselves to make healthy choices that will benefit the emotional and physical well-being of themselves and their children. We strive to help survivors identify the red flags of abuse, increase positive self-esteem, and have access to relevant resources and options. During the fiscal year, our Community Counseling and Advocacy Program served 715 adult clients

My Sisters' Place offers free legal services in the areas of family law and immigration law to victims of domestic violence and human trafficking and their dependent children. Legal services include direct representation of clients in court, legal advice and counsel, and administrative advocacy. With the goal of keeping both clients and their children safe, our family law attorneys and advocates assist victims in both the civil and criminal courts with Orders of Protection, custody, visitation, and child support matters. Our family law attorneys and advocates provided direct legal advocacy and/or representation to 462 victims of domestic violence and their children during the fiscal year. Our immigration and human trafficking team provides legal
