BECAUSE OF THESE INITIATIVES, AFB CONTINUES TO ACHIEVE INCREASES IN VISITORS AND VISITS TO ITS SITE THAT ARE WELL IN EXCESS OF THE 11% BENCHMARK FOR NONPROFIT WEBSITES. VISITORS TO AFB'S WEBSITES VIEWED MORE THAN 10 MILLION PAGES LAST YEAR. BASED ON A COMPETITIVE ANALYSIS, "WE BELIEVE THAT AFB.ORG AND ITS FAMILY OF WEBSITES RECEIVE MORE VISITORS THAN ANY OTHER VISION LOSS NONPROFIT IN THE WORLD." AFB'S CAREERCONNECT PROVIDES COMPREHENSIVE EMPLOYMENT INFORMATION, JOB READINESS SKILLS, PEER AND MENTOR SUPPORT, AND SELF-ADVOCACY GUIDANCE TO EMPOWER JOBSEEKERS WITH VISION LOSS. IT IS THE NATION'S LEADING ONLINE PROVIDER OF EMPLOYMENT AND JOB SEARCH INFORMATION DEVELOPED SPECIFICALLY FOR THE VISION LOSS COMMUNITY. IN FY15, VISITORS TO CAREERCONNECT GREW BY 28% AND PAGE VIEWS INCREASED BY 51%. CAREERCONNECT NOW FEATURES A NEW SOCIAL NETWORKING PROFILE AND A SOCIAL MEDIA PRESENCE. ENHANCEMENTS WERE MADE TO KEY CONTENT SUCH AS THE POPULAR "OUR STORIES," CAREER CLUSTERS, AND THE CAREERCONNECT BLOG, WHICH NOW INCLUDES VIDEO POSTS. A COURSE FOCUSED ON MAINTAINING & ADVANCING IN EMPLOYMENT WAS ADDED TO THE SITE ALONG WITH ENHANCEMENTS TO LESSON PLANS FOR TEACHERS AND PROFESSIONALS. THE CAREERCONNECT APP, DESIGNED TO BE USED ON THE GO FOR JOB SEARCH TIPS, QUICK LESSON IDEAS, AND CAREER ADVICE, LAUNCHED IN FY 2014, WAS UPDATED TO SUPPORT THE SOCIAL NETWORKING FEATURES OF THE CAREERCONNECT WEBSITE. THE APP ALSO RECEIVED MANY INTERFACE IMPROVEMENTS AND ENHANCED SHARING CAPABILITIES. FAMILYCONNECT, CREATED BY AFB AND THE NATIONAL ASSOCIATION OF PARENTS OF CHILDREN WITH VISUAL IMPAIRMENTS (NAPVI), PROVIDES A VIRTUAL LIFELINE TO CONNECT PARENTS AND FAMILIES TO RELIABLE INFORMATION, RESOURCES AND EACH OTHER, TO SUPPORT RAISING CHILDREN WITH VISION LOSS FROM BIRTH TO SUCCESSFUL ADULTHOOD. IN FY15, VISITORS TO FAMILYCONNECT GREW BY 39% AND PAGE VIEWS INCREASED BY 16%. THE PROGRAM CONTINUES TO EXPERIENCE CONSISTENT USE OF BOTH ITS INFORMATIVE ARTICLES AS WELL AS SOCIAL NETWORKING THROUGH BLOGS AND MESSAGE BOARDS. THE PROGRAM ALSO RECEIVED HIGHLY FAVORABLE RATINGS FROM A SURVEY OF VISITORS WITH 86% RESPONDING THAT THE FAMILYCONNECT WEBSITE HELPED THEM FEEL MORE CONFIDENT ABOUT RAISING THEIR CHILD. FAMILIES REPORT THAT THEY USE FAMILYCONNECT AS A VIRTUAL LIBRARY TO ANSWER THEIR QUESTIONS ON THE EDUCATION AND DEVELOPMENT OF THEIR CHILDREN WHO ARE BLIND. THEY CONNECT WITH OTHERS THROUGH BLOGS, MESSAGE BOARDS AND ANNOUNCEMENTS WHICH LEADS TO LESSENING THEIR FEELINGS OF ISOLATION (83% REPORT FEELING LESS ISOLATED). WITH FEW RESOURCES AND FAMILIES IN THEIR OWN COMMUNITIES, FAMILYCONNECT IS A TOUCHSTONE THEY USE FROM THEIR CHILD'S BIRTH TO TRANSITION INTO ADULTHOOD. AFB'S VISIONAWARE IS A FREE, EASY-TO-USE ONLINE RESOURCE CENTER FOR ADULTS WITH VISION LOSS, THEIR FAMILIES, CAREGIVERS, HEALTHCARE PROVIDERS, AND SOCIAL SERVICE PROFESSIONALS. IT INSPIRES AND EMPOWERS PEOPLE NEW TO VISION LOSS TO CARRY ON FULL LIVES BY PROVIDING HOPE, HELP AND CONNECTION TO SUPPORT AND SERVICES. THE SITE INCLUDES INFORMATION ABOUT EYE CONDITIONS ALONG WITH TIPS AND TECHNIQUES FOR LIVING WITH VISION LOSS, DEALING WITH THE EMOTIONAL ASPECTS OF VISION LOSS AND CARRYING OUT EVERYDAY TASKS. INDIVIDUALS CAN USE THE SITE TO CONNECT THROUGH MESSAGE BOARDS, BLOGS, AND JOIN THE VISIONAWARE COMMUNITY TO RECEIVE ALERTS OF NEW CONTENT AND SPECIAL ANNOUNCEMENTS. VISIONAWARE CONTINUED TO ACHIEVE EXCELLENT GROWTH IN THE NUMBER OF VISITORS, VISITS, PAGE VIEWS, AND SOCIAL MEDIA FOLLOWING. DURING FISCAL YEAR 2015, THE NUMBER OF VISITORS INCREASED BY 117%, VISITS INCREASED BY 97%, AND PAGE VIEWS INCREASED BY 55%. FURTHERMORE, RETURN VISITORS INCREASED BY 87%. VISIONAWARE'S TWITTER HANDLE CONTINUES TO HAVE THE HIGHEST NUMBER OF FOLLOWERS IN THE VISION LOSS FIELD, UP TO 10,000, A 25% GROWTH.
