KidsCareEverywhere is a 501(c)(3) public charity dedicated to transforming pediatric care in under-resourced communities by enabling doctors to care

KidsCareEverywhere helps impoverished children in the developing world through integrating information technologies into everyday healthcare
delivery systems We do this by donating software called PEMSoft and training doctors and medical professionals in their use This software is available
primarily as a mobile app, resident on a smartphone Web based versions are also available PEMSoft is gifted to KCE by EBSCO Health, Ipswich, Ma

During the fiscal year 2013 - 2014, KidsCareEverywhere visited and trained doctors and medical professionals in 8(locations in 5 developing
countries KCE members donated almost 700 hours in these field locations to provide these services Details by country follow

Colombia, South America a KCE team of 12 trained at 4 hospitals in 3 cities in June 2015 Hospitals included Hospital Universidad (Cali), Fundacion

Part IX Line 3 Contributed expenses totalled \$295,000. This represents PEMsoft Medical Software, donated by EBSCO Health.

PEMSoft software is gifted to KidsCareEverywhere by EBSCO Health in Ipswich, Massachusetts. PEMSoft is primarily a mobile phone based app. PEMSoft is a vast, powerful electronic knowledge system with thousands of topics, interactive modules, and an extensive library of photographs, drawings and videos. PEMSoft software is a constantly updated, multi-media state of the art pediatric knowledge system licensed commercially in the TI USA and Western world. The software is available as a mobile app for smartphones which is downloadable to the native memory of the phone (no need for internet access or electricity), as well as a Web app. KidsCareEverywhere donates the software and trains doctors and medical professionals. In general, the FMV of a large hospital setting is \$50,000 per site, for a smaller hospital, the FMV is \$15,000. The cumulative FMV of the PEMSoft licenses received and distributed during the fiscal year ended June 30, 2015 was \$295,000. The included five large hospitals and three small hospitals.
