This funded the final outstanding amount on the mortgage for the Aschiana Children's Center in Kabul where programs and operations for all of Afghanistan are conducted.

4c (Code: _____) (Expenses \$ 49,070 including grants of \$ _____) (Revenue \$ _____)
This program provided 255 students in Mazar-i-Sharif and 200 students in Gardez twith basic remedial education to get them to grade level to matriculate to the regular public school system. The funds were used for teacher salaries, classroom rental space and school supplies.
