In the case of FIRST Robotics, FIRST (EIN Number 22-2990908) is the primary organization operating FRC Robotics in the United States and was the primary organization to run the Midwest Regional FRC Championship in April 2015. Insite Illinois received donations for multiple donors to fund the program in Illinois. This grant to FIRST represented donations received by Insite Illinois for the FRC program in Illinois.

For the individual teams, Insite Illinois receives funding with some limited restrictions to fund individual teams. Teams are provided grants after providing receipts showing matching expenses for their robotics teams. Often this funding involves teams chosen to attend national or international championship tournaments. Insite Illinois separately tracks the restricted donations and provides grants only after receiving evidence of expenses related to robotics education activities. The restrictions are time bound and after one year Insite Illinois is free to use the funds as unrestricted contributions should teams not demonstrate expenses used for robotics education.
