The organizations primary exempt purpose is charitable fundraising to support further research to fight childhood cancers. St. Baldricks Foundation, Inc. promotes increased awareness and financial support for childhood cancer research through fundraising events and activities. Charitable funds raised, exclusive of expenses, are donated to childhood cancer research institutions via a vigorous scientific peer review process. St. Baldricks Foundation mobilizes patient-advocates, volunteers and the community to engage with their federal and state legislatures thru digital advocacy, sharing their stories and encouraging legislators to support greater awareness of and support for childhood cancer issues. In conjunction with the Foundations staff, patient-advocates also visit their legislatures in state and national offices to further awareness and support.
