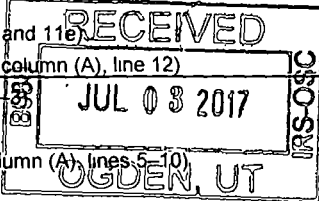

Board Members are required to communicate conflicts to full Board and remove themselves from discussion of the topic.
