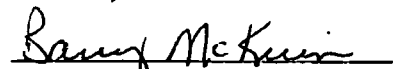
FURTHER RESOLVED, that all acts authorized by the foregoing resolutions herein are hereby ratified as the authorized acts of the Corporation.

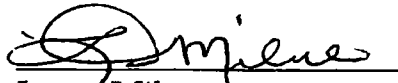
