Legacy's 200 Elementary students (grades PreK-4) benefit from small classroom sizes taught by certified teachers. An extensive offering of elective classes provides exciting and well-rounded enrichment opportunities. Legacy's students are perennial recipients of awards in regional spelling bee and math and art competitions.

(Code) (Expenses \$ 604,302 including grants of \$) (Revenue \$ 769,616)

Legacy's Middle School program (grades 5-8) had enrollment of approximately 100 students. Middle School students at Legacy consistently do well in the regional science fair and regional math and art competitions. They are able to begin competing on Legacy athletic teams. Starting in Middle School, students take leadership classes, with a curriculum focused on strengthening the foundations of their faith and being able to share and defend it. Middle School students outperformed the national average in every category of the TerraNova standardized test.

Legacy has close to 100 High School students (grades 9-12). The University Model schedule prepares students for an easy transition to a university schedule. Graduates have been accepted, have received scholarships, and are attending major universities. Students in grades 9-11 took the PSAT and scored higher than the national average in each grade. High School students compete in 10 sports in the TAPPS league. Leadership classes and weekly Rebelution meetings before school continue to prepare high school students for life after high school.
