The goal of this program is to both increase public education and to raise money for further research and screening capabilities. This program also includes the development of a new bill regarding heart screening for student athletes and the efforts to get the bill passed in all 50 states.

Medical Screenings - To provide free heart screenings to all students throughout the Philadelphia region.
