This program also includes the development of a new bill regarding heart screening for student athletes and the efforts to get the bill passed in all 50 states.

Medical Screenings - To provide free heart screenings to all students throughout the Philadelphia region.

Development of a registry database to compile the results and medical images from the heart screenings that are performed by Simon's Fund. Once this database is operational, the goal is to offer restricted access to it to researchers who are studying heart defects that cause sudden cardiac arrest.
