Legal aid: Asylum Access's legal advocates provide direct legal assistance to help asylum-seekers obtain refugee status, the first step to accessing all other rights in a country of refuge, ensuring they are not wrongly denied and have access to due process. In addition, we help refugees access other rights, such as the right to work, and respond to rights violations, such as owed wages and labor disputes. This year, we continued to respond to a high demand for legal aid by refugees and asylum seekers, serving over 20,000 refugees in Ecuador, Tanzania, Thailand, Panama, and Malaysia through legal information, advice, counsel and/or representation. Our work shows high success rates; the Refugee Status Determination (RSD) cases we represented this year in Ecuador, Tanzania and Thailand had higher success rates than the national average in each country.

Community Legal Empowerment: Community Legal Empowerment, through Know Your Rights and Know Your Options workshops, helps refugees to understand their rights and how to assert them. Refugee leaders receive training to provide basic legal assistance to others in their communities, and launch their own social justice initiatives with our support. To facilitate self-sufficiency, we organize refugee work rights workshops and women's empowerment groups. This year we reached approximately 10,400 refugees and asylum seekers and their dependents through Know your Rights and Know your Options training workshops in all countries, with specialized training on work rights in Ecuador. In Tanzania, 157 refugees were reached through Junior Achievement entrepreneurship trainings to help them access livelihoods, and Women's Empowerment Groups which help refugee women build resilience. In Ecuador over 450 women participated in Women's Empowerment Groups. In Thailand, 28 refugee interpreters were trained to help other refugees access legal aid in their native languages.

Policy advocacy: Policy advocacy and government engagement allow us to transform laws and practices so that entire refugee populations can enjoy their rights automatically. Our policy advocacy at the national and international levels affected over 1,000,000 refugees worldwide. In Thailand, joint advocacy with the Thai government led to the elimination of bail for refugee children held in detention. In Tanzania, we were invited to collaborate with the government to draft an urban refugee policy that would allow refugees to live and work outside camps. The Ecuador office led regional efforts to improve due process in RSD proceedings, testifying

before the Inter-American Commission on Human Rights on refugee rights in the region. Globally, Asylum Access continued to advocate for work rights for refugees, publishing the groundbreaking Global Refugee Work Rights report, which has been cited by numerous international actors such as UNHCR and the World Bank.

Asylum Access also uses Strategic Litigation and Movement Building to complete its holistic approach to refugee rights activism. We use strategic litigation to bring test cases before national and international courts, so that refugees may enjoy their rights automatically without having to fight for them. This year we brought a strategic case before the Committee to End All Forms of Discrimination Against Women that could establish domestic violence as a cause for refugee status. Finally, Asylum Access continues to work to expand the reach of our services, building a global movement for refugee rights. We opened three new offices in 2014-2015, in Malaysia, Panama and Mexico. The Refugee Rights Toolkit, an online resource combined with an individualized mentoring program, plays a key role in our strategy to identify and cultivate new international leaders in the refugee rights movement; this year we coached 2 refugee rights leaders in India and Indonesia.
