OF THE 169 FAMILIES WE SERVED, OVER 90% HAD NO REPORTED INCIDENTS OF CHILD ABUSE AND NEGLECT SIX MONTHS AFTER COMPLETION OF SERVICES. IN ADDITION TO WORKING DIRECTLY WITH FAMILIES, NEIGHBORHOOD PLACE OF PUNA RESPONDED TO OVER 600 REQUESTS FOR INFORMATION FROM THE COMMUNITY. WE ALSO PROVIDED EMERGENCY ASSISTANCE TO 1,256 FAMILIES OR 4,617 INDIVIDUALS. THAT IS OVER 48,000 POUNDS THAT WE DISTRIBUTED IN FY14-15. WE CONTINUE TO COLLABORATE EXTENSIVELY WITH OTHER ORGANIZATIONS TO ADDRESS ISSUES OF POVERTY, AND ENSURE THAT FAMILIES HAVE ACCESS TO THE KNOWLEDGE AND RESOURCES NECESSARY TO RAISE SAFE AND HEALTHY CHILDREN.
