	AS THE NATIONAL LEADER OF THE URBAN DEBATE MOVEMENT, THE NATIONAL ASSOCIATION FOR URBAN DEBATE LEAGUES (NAUDL) WORKS WITH ITS PARTNER LEAGUES TO PROVIDE DEBATE PROGRAMMING TO URBAN MIDDLE AND HIGH SCHOOL STUDENTS. IN 2015, NAUDL AND ITS LEAGUES SERVED 9,479 URBAN DEBATERS FROM 584 PUBLIC SCHOOLS IN 19 CITIES ACROSS THE UNITED STATES. SEVENTY-TWO % OF OUR STUDENTS ARE FROM LOW-INCOME FAMILIES AND 84% ARE STUDENTS OF COLOR. STUDENTS IN LARGE URBAN SCHOOL DISTRICTS HAVE LITTLE MORE THAN A 50% CHANCE OF GRADUATING FROM HIGH SCHOOL. URBAN DEBATE KEEPS STUDENTS IN SCHOOL. AN INDEPENDENT, PEER REVIEWED TEN-YEAR RESEARCH STUDY FOUND THAT 90% OF THE DEBATERS GRADUATED ON TIME, COMPARED TO ONLY 75% OF SIMILAR STUDENTS WHO DID NOT DEBATE. AMONG STUDENTS WHO ARE MOST AT-RISK, STUDENTS OF DROPPING OUT, 72% OF DEBATERS GRADUATE, AS COMPARED WITH 43% OF NON-DEBATERS. EVERY SEMESTER THAT A STUDENT DEBATES HIS OR HER GRADES IMPROVE. AT GRADUATION, URBAN DEBATERS HAVE A CUMULATIVE GPA OF 3.23 AS COMPARED TO 2.83 FOR NON-DEBATERS. RESEARCH ALSO SHOWS THAT DEBATERS ARE SIGNIFICANTLY MORE LIKELY THAN SIMILAR NON-DEBATING STUDENTS TO SCORE AS COLLEGE-READY ON STANDARDIZED TESTS IN SCIENCE (27% MORE LIKELY), READING (15% MORE LIKELY), ENGLISH (15% MORE LIKELY), MATH (10% MORE LIKELY). URBAN DEBATERS REPORT SIGNIFICANTLY HIGHER LEVELS OF SCHOOL ENGAGEMENT, OR ACADEMIC MOTIVATION, THAN SIMILAR STUDENTS WHO DO NOT DEBATE, AND THIS HIGHER LEVEL OF ENGAGEMENT IS ONE IMPORTANT REASON FOR THEIR HIGH SCHOOL SUCCESS. EIGHTY-FIVE PERCENT OF URBAN DEBATERS ATTEND COLLEGE. URBAN DEBATERS ARE 89% MORE LIKELY THAN NON-DEBATERS TO ATTEND A FOUR-YEAR COLLEGE OR UNIVERSITY AND 80% MORE LIKELY TO EARN A DEGREE WITHIN 6 YEARS.
