During the eighth year of operation, the 2014-2015 school year, Foundation Academy Charter School provided a full range of educational services appropriate for all students in Kindergarten, and Grades 3 through 12. The Educational program includes social, health and nutrition services that support the total education of the student. In addition, the educational services include regular, as well as special education instruction. Foundation Academy Charter School promotes the full involvement of parents in their children's educational development. The Charter School completed the 2014-2015 school year with the following enrollment: 156 primary school students in Kindergarten and Grade 3, 162 intermediate school students in Grades 4 and 5, 224 middle school students in grades 6-8, while an additional 224 high school students were enrolled in grades 9 thru 12. The Average Daily Enrollment (ADE) for the entire charter school for the 2014-2015 school year was 757 students.
