The Chaplain's Office strives to promote faith development, personal reflection, and religious understanding through a range of programs and services. Groups and events included (1) Cornerstone, a community of campus Christians exploring or desiring to deepen their Christian identity, (2) Sanctuary, a monthly mass/chapel service, (3) Interfaith Dialog, where religious intolerance is challenged by examining sacred texts from each tradition, and (4) Theology on Tap, where discussions and exploration of topics are led by the Chaplain and Endicott faculty. Guest speakers were engaged to bring messages of tolerance, nurturing healthy conflict, and motivation

Community service programs included retreats, Relay for Life, Alternative Spring Break, and Family Promise, a program where volunteer students worked with homeless families. Volunteers also partnered with Habitat for Humanity to build homes.

Chapel Improvements during the fiscal year included the acquisition of a new sound system.
