NEPAL - APRIL 2015 EARTHQUAKE RELIEF: MOBILIZED A VOLUNTEER TEAM THAT RAISED THE FUNDS AND EXECUTED OPERATIONS THROUGHOUT NEPAL TO PROVIDE ACCESS TO CLEAN WATER. THE PRIMARY ISSUE AFTER THE EARTHQUAKE WAS WATER FILTRATION. THIS EFFORT LED TO THE DISTRIBUTION OF 1,275 SAWYER POINTONE WATER FILTERS TO FAMILIES, MEDICAL CLINICS, SCHOOLS, AND COMMUNITIES. USAGE AND UPTAKE WERE GREATLY ENHANCED DUE TO A COMPREHENSIVE TRAINING AND EDUCATION PROGRAM THAT WAS INCLUDED WITH THE DISTRIBUTION OF THE FILTERS.
