	In 2014-2015, Georgian Court University served more than 2,300 students in more than 31 undergraduate and 9 distinctive graduate programs through the School of Business, School of Education, and School of Arts and Sciences, as well as the GCU-Meridian Health School of Nursing. The university also offers online degrees and specialty certificates in such fields as holistic health, homeland security, and education. Georgian Court, located in historic Lakewood, New Jersey, is the only Catholic institution of higher education serving residents throughout Central and Southern New Jersey. The university has historic roots as a women's college, and served men in evening and graduate courses-usually part-time-until September 2012. Beginning that year, men enrolled full time in any course, and GCU became fully coeducational in September 2013. Today, GCU is fully coeducational with men participating in sports, student government, campus ministry, campus leadership, and residence life. GCU provides all students with a values-based liberal arts experience that enhances their marketability across various disciplines and emphasizes purposeful leadership. GCU graduates contribute to the greater good locally, nationally, and throughout the world. GCU's 13:1 student-faculty ratio allows students to learn in small classes that foster valuable research opportunities between professors and students. In 2014, 84% of GCU seniors completed at least two high-impact learning experiences such as faculty-student research, study abroad, service learning and internships, among similar mid-East colleges and universities, only 75 percent did so (2014). In addition, small classes with approachable faculty are especially helpful at GCU where adult learners (ages 23 or older) comprise about 26 percent of the student population. Nationally, alumni of independent colleges and universities are more likely (62 percent) to say they benefited very much from classes with fewer than 20 students, among public university graduates, about 15 percent say they benefited from small classes. In recent years, GCU has added new areas of study that reflect market demands and employment trends. Examples include the university's graduate program in applied behavior analysis and the GCU-Meridian Health B.S.N. in Nursing program. In May 2015, the university graduated its fourth class of B.S.N.-prepared nurses-some of whom are working in hospital settings and others who plan to pursue healthcare management careers. The university also saw several accolades in 2015, including the School of Education's accreditation for its M.A. in Administration and Leadership from the Teacher Education Accreditation Council, a quality assurance report from the Accreditation Council for Business Schools and Programs, the New Jersey Governor's Environmental Excellence Award, and a score of 3-the highest possible mark-on the U.S. Department of Education's financial responsibility test. The 2014-2015 academic year saw an increase in students' academic credentials. For example, in Fall 2014, the average incoming freshman had a 3.21 GPA, up from 3.05 in Fall 2013. The retention rate for Fall 2014 students living on campus also climbed to 90 percent, up from 88 percent the prior year. The university also launched an intensive retention effort for all first-year students at risk of not completing 30 credits by the end of their freshman year. The program, Chart the Course, offered a free course over winter break and summer break to qualified students. Initial results found that 86 percent of participating Chart the Course students were retained, versus the class average of 78 percent. GCU provides opportunities for valuable experience in academic disciplines before graduation. Students-including about 30 percent of seniors-report working alongside faculty mentors in disciplines like social work, biochemistry, business, autism studies, early childhood education, learning disabilities consulting, and school psychology. Overall, at least 65 percent of GCU seniors participate in an internship, field experience, student teaching, or clinical placement before graduation. Also by senior year, 51 percent of GCU students have experienced courses that include a community-based project, compared to only 10 percent of students at other mid-East private colleges and universities. Service, one of GCU's Mercy core values, is embedded in the university's myriad experiences, as evidenced by the 94,000+ volunteer hours GCU students, faculty and staff invested during the 2014-2015 academic year. Many of these experiences are managed by the Office of Mission Integration, which expanded its programming in 2015 to include the Office of Campus Ministry, the service-focused Mercy Collegiate Society, vocational and spiritual retreats, and the annual Critical Concerns Week, which focuses on social justice issues and activities. Additional partnerships and programs at locations throughout the region extend the reach and mission of Georgian Court University. Among them are the Guaranteed Tuition Initiative with neighboring Brookdale Community College, GCU's largest two-year college feeder, and the M.A. in Administration and Leadership program especially for Catholic school educators, its first class of graduates completed the program in May 2015 and included students now working as principals and school leaders throughout the Diocese of Trenton. GCU's International Collaboration Center continues to connect GCU students and faculty with their peers in other countries. In 2014-2015, faculty and students conducted research, delivered course presentations, and completed collaborative projects with international partners using the ICC's technology. In addition, GCU's growing global education program sent more than 40 students and faculty members to places like Ecuador, Argentina, Hong Kong, Spain, and World War II commemorative sites throughout Europe. The university also partners with schools worldwide, including John Cabot University in Rome. On campus, GCU attracted academic leaders from around the world for the World War I Centennial Anniversary conference that examined the role of pacifists in wartime. Other professional conferences sponsored on the Georgian Court campus drew researchers in applied behavior analysis, clinical mental health counseling, graphic design, and holistic health. Overall, the university saw more than 22,000 visitors to campus in 2015. STUDENT NEED AT GCU About 99 percent of GCU's full-time first-year students receive aid, with an average financial aid package of \$31,884. About 43 percent all full-time freshmen receive Pell grants (federal aid). In addition, 45 percent of entering freshmen were first-generation students. The generosity of individual and foundation donors and the university's conservative approach to stewardship has allowed GCU to provide \$16 million in institutional aid to students. In 2015, the university's alumni giving rate was 10.2 percent, putting GCU on par with or better than some peer schools.

THE TEAMS ARE VERY ACTIVE IN COMMUNITY SERVICE THROUGH THE SUSAN B. KOMEN WALK FOR THE CURE, CANCER RESEARCH PROGRAMS, TEAM IMPACT, MAKE-A-WISH FOUNDATION, AND NATIONAL GIRLS AND WOMEN IN SPORTS DAY. THEY ALSO ACHIEVE IN THE CLASSROOM. IN 2014-2015, THE GCU LIONS ATHLETIC PROGRAM RECEIVED THE NCAA'S PRESIDENT'S AWARD FOR ACADEMIC EXCELLENCE, BASED ON THE ACADEMIC SUCCESS RATE (92 PERCENT) OF GCU STUDENT-ATHLETES WHO GRADUATE WITHIN SIX YEARS.
