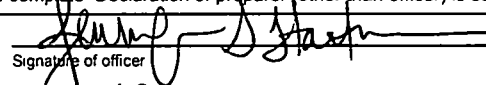
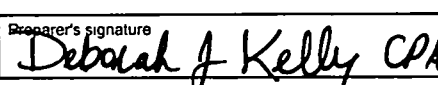

The Foundation helps to garner resources, through sponsorships and other funding streams, for institution specific, system-wide and multi-university collaborative programs. Other collaborative programs include, a student business plan competition, women's consortium, board of student government presidents, quality of work life committee, PACT, and other meeting/conferences that support the Foundation's mission throughout the year.
