Shelter Program: The emergency shelter program for single individuals housed 133 unduplicated individuals during this fiscal year for a total of 5,241 bed nights. Of those individuals, 33 were able to move into permanent housing without the assistance of a subsidy, an additional 20 clients moved in with family or friends on a permanent basis, 19 moved into transitional housing within WARM's programs or other resources, 34 did not complete the program or were asked to leave. Of those individuals that completed the program, 77 were able to secure full or part time employment.

4b (Code) (Expenses \$ **246,698** including grants of \$) (Revenue \$ **51,178**)

Harvest Homes: In fiscal year 2015, the Harvest Homes program provided housing for 23 homeless families consisting of 23 Adults and 40 children as well as an additional 21 individuals. Without the resources of Harvest Homes, these families and individuals may have been homeless and in a shelter. Of the families who completed the program, 18 went on to permanent housing without subsidy and one returned to a shelter. Of the 21 individuals who participated in the program, 4 went on to permanent housing without a subsidy and 2 received section 8 housing. All of these families and individuals left having increased income and housing stability.

4c (Code) (Expenses \$ **65,298** including grants of \$) (Revenue \$)

Outreach: The WARM Center was the fiscal agent for a grant from the Rhode Island Foundation in the amount of \$50,000 to assist the community with basic needs such as rent, utilities, prescriptions and other basic human needs. This resource enabled WARM to collaborate with other agencies throughout Washington County to provide assistance to 303 households consisting of 463 adults and 334 children. In all cases, this financial assistance prevented a further decline of these families and individuals into poverty and homelessness. The fact that the Rhode Island Foundation reached out to WARM to apply for this assistance grant, continues to show WARM's standing in the philanthropic community.
