Brandywine Ballet's Resident Choreographer, Nancy Page, created Dracula in 2004. Over this ten year time frame the ballet has evolved into one of our dancer's, artistic staff's and audience's favorite ballets. A tale of true love that spans hundreds of years. Romance mingles with heartbreak, anger and lust - ultimately love releases those bound to the fate of the Vampire and peace is restored. High levels of technicality and emotion are brought forth from our dancers, providing the audience with an enriching and connective experience

Winter 2014 The Nutcracker Ballet - a full length semi-professional ballet, 8 performances

The Nutcracker is a beloved Holiday Tradition amongst families all over the world. Brandywine Ballet is proud to present this revered classic for the 35th time. This ballet is our highest grossing production, and 2014 was the highest grossing year to date. Our audience continues to grow as does the quality of our production. One of the reasons for this sustained growth is the ballet's heralding of the holiday season, and the fact that it brings families together - providing them with memories for years to come. Dancers from the smallest to the most seasoned share the stage in this production. This mingling of different levels of dancers shows the children in the audience that they too can do whatever they set their minds to, like the children up on the stage. Watching the progression from the Angels to the Sugar Plum Fairy is magical in itself, and it is an aspect of the ballet that resonates throughout the audience and throughout the cast on stage

Spring 2015 Sleeping Beauty - a full length semi-professional ballet, 4 performances

Sleeping Beauty is the third storybook ballet that Brandywine Ballet has brought to the stage in four years. This is indeed an accomplishment. Our Board of Directors made a decision in 2011 to expand the company's repertoire with a series of family-friendly, full-length story ballets. This decision was made based on a handful of reasons. One of the reasons was the traditionally low attendance of the spring series. In bringing Sleeping Beauty, Beauty and the Beast, and The Wonderful Wizard of Oz to the stage, Brandywine Ballet has increased the spring audience size by 50%-75%. Sleeping Beauty is a special addition, because it is based after the original choreography of Marius Petipa. This ballet was very technically demanding, and our dancers met this challenge with dynamic grace. Our audience was "wowed" by the production as a whole, from the exciting story line, to the technical prowess of the dancers, to the beauty of the costumes, staging, and lighting - all contributing to bringing a high quality artistic experience to the suburbs
