ON JANUARY 1, 2012, THE FOUNDATION SOLD SIGNIFICANTLY ALL OF THE ASSETS OF ITS SUBSIDIARIES, MOSES TAYLOR HOSPITAL, PHYSICIANS HEALTH ALLIANCE, MID VALLEY HOSPITAL, AND MOSES TAYLOR RESOURCES TO SCRANTON QUINCY HOLDINGS. AFTER THE SALE, MOSES TAYLOR FOUNDATION CHANGED ITS BENEFICIARY FROM MOSES TAYLOR HOSPITAL TO THE RESIDENTS OF LACKAWANNA COUNTY, PENNSYLVANIA AND THE SURROUNDING AREAS IN NORTHEASTERN PENNSYLVANIA. MOSES TAYLOR FOUNDATION HAS A HARD TIME COMPETING WITH OTHER LOCAL NONPROFIT ORGANIZATIONS FOR DONATIONS.
