OVER THE YEARS, MANY BOARD MEMBERS OF THE ALUMNI ASSOCIATION HAVE EVENTUALLY BECOME MEMBERS OF THE UNIVERSITY AND VICE VERSA. ALTHOUGH THESE TERMS WERE NOT CONCURRENT, IT IS REPRESENTATIVE OF THE DEPTH OF THE HISTORICAL RELATIONSHIP OF THESE TWO ORGANIZATIONS. THE UNIVERSITY HAS RELIED ON THE ALUMNI ASSOCIATION TO IMPROVE THE LINKS BETWEEN THE UNIVERSITY AND ITS ALUMNI. THESE LINKS HAVE ASSISTED THE UNIVERSITY IN ITS EFFORTS TO INCREASE THE QUALITY OF INSTRUCTION, EXPAND THE FIELDS OF STUDY AVAILABLE TO STUDENTS AND ENHANCE THE CAREER OPPORTUNITIES OF ITS GRADUATES. THE UNIVERSITY CONSIDERS THE SUPPORT OF THE ALUMNI ASSOCIATION VITAL TO ITS ON-GOING SUCCESS AS AN INSTITUTION OF HIGHER LEARNING.
