MISSION COMMUNITY BEACON - THE MISSION COMMUNITY BEACON AT EVERETT MIDDLE SCHOOL PROVIDES AFTERSCHOOL AND SUMMER PROGRAMMING, SCHOOL-DAY SUPPORT, AND PARENT ENGAGEMENT, THROUGH A COLLABORATION OF PROGRAM PARTNERS OF 150 YOUTH DAILY, AND REACHES UP TO 400 YOUTH A YEAR THROUGH ACADEMIC SUPPORT, LEADERSHIP DEVELOPMENT, AND ENRICHMENT OPPORTUNITIES.
