Centro Legal de la Raza's core legal services provide counsel, advice, referral, and representation to more than 9,000 individuals each year in the areas of housing, employment, immigration, consumer protection, workers' compensation, and personal injury While the organization’s expertise is working with monolingual Spanish-speakers, it provides services to all low-income people in need regardless of race or ethnicity Key programs include the Tenants' Rights Program which prevents homelessness by providing free eviction defense services for low-income tenants, the Workers' Rights Project which helps low-wage workers and day laborers fight to obtain earned but unpaid wages, and the Immigrants' Rights Program which assists immigrants in all areas of immigration law including deportation defense, naturalization services and U visa assistance

Centro Legal de la Raza's Youth Law Academy is building a diversity pipeline into higher education and the law by helping low-income youth of color enroll in and graduate from college, as well as explore professional careers The first phase is a three-year after-school program that provides comprehensive support services to help youth graduate high school and prepare for college The second phase is a college component, which helps students transition to college with a plan to fund their education and provides ongoing case management to ensure persistence
