"Economics for Success" provides hands-on experience, tools for learning and understanding financial literacy, exercises for up to two grade levels (up to 8th grade) and work readiness while in the classroom environment. "Money Smart Week" is a series of free workshops and activities designed to help consumers better manage their personal finances. Current efforts are concentrated on the "Economics for Success" program.
