A donation of \$3,000 went to Special Olympics South Dakota. Donations of \$500 were made to two (2) organizations (Make-A-Wish and SDFCA) for a total of \$1,000. One (1) grant in the amount of \$700 was awarded to a coach to attend a national clinic or seminar. Assistance in the amount of \$12,691 total was given to nineteen coaches to attend a national clinic. The organizations all contribute to the exempt purpose of the organization. The organization also provides coaches across the state at a clinic to better themselves for the benefit of students they coach.
