The three largest cost centers for Manchester Bidwell Corporation (MBC) in fiscal year 2014-15 were Administration, Finance, and Facilities THE Following are THE accomplishments related to these areas in fiscal year 2014-15 In fiscal year 2014-15, MBC updated the Heating, Ventilation, & Air Conditioning (HVAC) systems in the primary campus building at 1815 Metropolitan Street Four older roof-top units were replaced and a new heat pump for the Design Arts Studio was added Mechanical dampers, variable air volume (VAV) units and re-heaters were installed in the Chemical Lab, Youth Administration and Cafetera to increase the comfort of those areas A heated vestibule was built around the rear entrance of the building to help increase the comfort of the lobby and cafetera especially during the winter months In fiscal year 2014-15, MBC also replaced the fifteen year old tables and chairs in the cafeteria which were well past their useful life The new chairs can easily be stacked on dollies and the tables tilt up and are on wheels which allow much easier moving and storage DURING TIMES WHEN THE cafeteria is used for events In fiscal year 2014-15, MBC replaced two Information Technology (IT) servers and a storage area network (SAN) that were damaged by water that came in from a roof penetration for the server room HVAC equipment MBC also replaced the network’s ten Wireless Access Points (WAPs) with more robust and stable Cisco Meraki Cloud WAPs as wireless is being used more frequently both in classrooms and meeting areas
