Part II (b)(1) -- The Vista School operates a day school and provides other educational and therapeutic programs for children diagnosed with Autism Spectrum Disorder employing the principles of Applied Behavior Analysis.

Part II (b)(2) -- The primary purpose of Vista Adult Services is the provision of housing, job support, behavioral care, and related services to adult individuals with Autism Spectrum Disorder.

Part V (2)(d)(1 & 2) -- The Vista Foundation holds a bank line of credit to meet working capital needs to fund its operations and those of its affiliates. As of June 30, 2015, there was an amount due to The Vista Foundation from Vista Adult Services of \$236,917 and due to The Vista School from The Vista Foundation of \$10,006.

Part V (2)(d)(3) -- The Vista Foundation and its related entities share facilities and have centralized purchasing for economy and efficiency. Through intra-company billing, each entity's appropriate expense is controlled and these balances are regularly settled. As of June 30, 2015, a balance of \$159,536 was due to The Vista Foundation from The Vista School and a balance of \$183,822 was due to The Vista School from The Vista Foundation.

Part V (2)(d)(4) -- The School paid a Management Fee to The Foundation in the amount indicated to reimburse The Foundation for certain administrative and managerial functions performed by Foundation employees in support of operations of The School pursuant to the Management Agreement between The Vista School and The Vista Foundation dated July 1, 2014.

Part V (2)(d)(5) -- Vista Adult Services paid a Management Fee to The Foundation in the amount indicated to reimburse The Foundation for certain administrative and managerial functions performed by Foundation employees in support of operations of VASO pursuant to the Management Agreement between VASO and The Vista Foundation dated July 1, 2014.

Part V (2)(d)(6) -- During the year ended June 30, 2015, The Vista School reimbursed The Vista Foundation \$444,573 which represents revenues received for services that were performed by employees of The Vista Foundation.
