OUR DEDICATED FACULTY AND STAFF ARE LIFE-LONG LEARNERS WHO ARE INVESTED IN OUR SCHOOL AND STUDENTS. OF OUR 33 EMPLOYEES OVER HALF HOLD ADVANCED DEGREES. OUR AVERAGE CLASS SIZE IS 17.1 AND OUR STUDENT-FACULTY RATIO IS 8.1. AS AHS CONTINUES TO ADD GRADE STUDENT'S, IT'S INSTRUCTIONAL, ADMINISTRATIVE AND FACILITIES EXPENSES INCREASE.
