	The seventh annual Tucson Festival of Books was held March 14 and 15, 2015 on the University of Arizona campus. Authors, exhibitors and book lovers of all kinds attended the festival which attracted more than 130,000 people to the UA campus and raised \$216,000 to advance literacy and education in Southern Arizona. The 2015 festival attracted more than 350 authors, 275 exhibitors and staged a multitude of activities. The Rock Bottom Reminders Band performed with over 1800 in attendance, hundreds of presentations and discussions, workshops for aspiring authors, book signings, free book give-away distributed over 6,000 titles in the Childrens area, dozens of hands-on activities conducted in Science City, and much, much more. Over 2,500 festival volunteers assisted with managing the event during the weekend.
