

Maryland-DC Campus Compact (MDCCC) promotes the public purposes of higher education by connecting campuses with their communities throughout the MD-DC region. MDCCC is a membership association of college and university presidents and their institutions committed to promoting engaged citizenship as an aim of higher education. MDCCC serves its member institutions through networking, grants, resources, and programs with the goal of developing deeper campus-community partnerships.

MDCCC AmeriCorps VISTA Grant: MDCCC addresses and alleviates poverty in the Maryland-DC region through our federally funded MDCCC AmeriCorps VISTA Grant <https://www.mdccc.org/ameriCorps/vista/abstracts-15-16.html>.

Through this grant we provide up to 25 full-time "positions" to develop and expand anti-poverty partnerships between our higher education institution members and community based organizations/ non-profits/ or local schools and school systems in the region. Through data from our annual survey, we estimate that our member institutions' students contribute a minimum of \$400 million in services annually to our region. The VISTA grant is a value of \$1.5 million to our members and communities. Our projects represent a smorgasbord of foci ranging from financial literacy, work force development, mentoring, veterans initiatives, ESOL programming, college access, college completion, to food security. We also develop and run a leadership and professional development program for the AmeriCorps VISTA members who are giving a year or more of their lives to build these partnerships and improve our communities.

Presidents' Institute and P-20 CONNECTS Collective Impact Partnerships:

Annually the MDCCC convenes its Presidents' Council, (all our member presidents) through our Presidents' Institute. For the past several years we use this event to convene a region-wide conversation about "what higher education can do together that we cannot accomplish as single/isolated institutions." As a result, our network of 36 higher education institutions have collectively agreed to and committed to partnering with K-12 schools and school systems to enhance the P-20 pipeline for college readiness, career readiness, and civic and community readiness. In 2015, we convened a P-20 CONNECTS Implementation Task Force, working very closely with K-12 partners such as the Maryland State Department of Education, the Public School Superintendents Association of Maryland and the District of Columbia Public Schools and Charter Schools to, together, discern how to better "connect the dots" at the policy-level to enhance equitable access to and completion in higher education. This Task Force issued a white paper on College, Career, and Civil Readiness through Civic Education. <https://www.mdccc.org/events/files/white-paper-2015.pdf>

Professional development workshops, retreats, and mini-grants:

Another area of our impact is providing professional development opportunities for faculty, staff, students and other constituents in our membership. We annually sponsor a Service-Learning and Civic Engagement Conference for 300+ faculty and students, 6 annual retreats including a "Practitioners' Retreat" for engagement professionals, and numerous workshops on service-learning, grant-writing, effective team building, volunteer recruitment, professional writing and (federal) report writing, etc. We also provide mini-grants to member institutions to promote faculty development which enhances service-learning, building a culture of engagement on a campus, community-based learning, and rewarding the scholarship of engagement in the promotion and tenure process. <https://www.mdccc.org/events/slce.html>

Other employees of the organization have had their salaries set by the executive director after extensive due diligence and benchmarking,

Organization's annual non-profit salary survey data.
