Organizational Capacity Development San Diego Social Venture Partners (SDSVP) strives to improve the overall effectiveness of impactful nonprofits in the San Diego area so that they, in turn, can help more people. As part of this program, SDSVP provides unrestricted grant funding coupled with pro-bono consulting from member Partners to help strengthen the business side of nonprofit organizations. SDSVP also provides tactical and consultative support on an as-needed basis to nonprofits through its resource teams of member Partners. Finally, SDSVP provides ongoing learning opportunities for individual philanthropists to ensure they are strategic and informed in their funding decisions and effective partners to nonprofits.

Advance San Diego Modeled on the venture capital fast-pitch model, San Diego Social Venture Partners Advance San Diego program provides thirty nonprofits in the San Diego area the opportunity to deepen their capacity to concisely convey the power of their work. Participating organizations are provided free training sessions and one-on-one mentoring from local business leaders to improve their 3 minute pitches. Each organization is given the opportunity practice this pitch in front of a live audience and then the most compelling organizations deliver their pitch in front of a much larger audience where local judges award cash prizes for the best conveyed and most impactful message. This program thereby increases participating organizations organizational capacity, provides funding to high performing nonprofits, and creates a platform that highlights the incredible work of nonprofits in San Diego.
