We participated in the 4th Annual Siri Guru Granth Sahib Conference in San Jose California. We sent teachers to India and the UK. We conducted and participated in our domestic youth camp, Camp Miri Piri in New Mexico. We produced a completely original educational animated film entitled "Kaur" which was released online and on DVD. We created two new free smartphone apps the SGGS Katha App for iOS and the Hukamnama App for Android (last year we released the iOS version.) In addition we maintained our existing, ongoing services including: Youth Q&A forum, Inspirations Videos, Daily News, SikhNet Radio and the Gurbani Media Center online.
