Musica Barroca Mexicana: Music from the Durango Cathedral Archive, 3 concerts, Fall 2014. Realize and perform music composed or performed at the Durango Cathedral in Durang, Mexico in the 1700s. Three concerts performed in Chicago and Evanston, Nov., 7, 8, 9. Each concert was preceded by a talk about the Durango Cathedral's history and archives, the challenges in researching and reconstructing the music. A slide show of the original manuscripts accompanied the talk.

Music from the World of Copernicus: Music from the Poland of the 15th, 16th, and 17th centuries, including areas now part of Latvia, Lithuania, Ukraine, Belarus, Czechoslovakia, and Germany. Bilingual programs were provided. Three concerts in Chicago and Evanston, March 20, 21, 22. Each concert was preceded by a talk on the sources, historical background and types of music.

Mr. Dowland's Midnight: An Evening of Elizabethan Blues. Songs and Music of John Dowland (1536-1626) and his contemporaries performed on both original and copies of original instruments in various arrangements. Each concert was preceded by a talk on the sources and arrangements as well as an account of the finding and restoration of the virginal used in the concert.
