KNOM's mission is to inform, educate, inspire, entertain and provide companionship for listeners in remote Western Alaska.
KNOM's listeners (numbering 20,000-30,000 people) are spread across 100,000 square miles; most live in villages along the
Bering Sea Coast and eastward toward the Alaskan interior.

Digital Studio Capital Project construction continues. Nearly all of the structure is built, with final wiring and trim to come in the fall of 2015. This project will replace aging, outdated, slow and unrepairable equipment with modular, energy efficient, wi-fi ready digital equipment. As the TERRA Band (fiber optic network for Western Alaska) makes its way North to Nome, KNOM is poised to take full advantage of greatly increased bandwidth capacity with digital production and broadcast equipment. Further, when fully functional, remote repair will be possible via a secure virtual network to diagnose and fix problems that may arise or be prevented.
All construction project expenses are capitalized to fixed assets.

Equipment will be purchased in Fall, 2015, with installation in winter, Jan/Feb 2016. The new studios are expected to be ready for use in March 2016. To date, the multi-year capital campaign has raised \$833,865 of the \$1,000,000 goal

In the spring of 2015, the KNOM Radio Mission board of directors adopted the final version of KRM's strategic plan. The plan was facilitated by consultants from the Foraker Group. The costs included consulting fees and a little more than \$2000 in travel expenses to bring the board of directors together to design the plan. The KRM strategic plan is built on the value pillars of 1) being friend and companion to listeners, 2) providing respectful service to the people living in Western Alaska, and 3) honors the mission's Catholic ideals.

KNOM continues to serve the people of Western Alaska. As internet becomes prevalent in remote Alaska, listeners are consuming KNOM's content - including news, local programming, emphasis on Native culture - in two ways: on the radio and online.
Listenership is now both actual and virtual.

Expenses include all ordinary program related expenses, revenues include contracted volunteer net time and program underwriting.
