Part V Line 2 - The organization shared some staff with the Congressional Leadership Fund, a related organization. For a portion of the tax year such staff were employed by a third party employee leasing company and for another portion of the tax year such staff were employed directly by the Network, and time spent working for each organization was tracked. The Network paid the portion of the third party's services fee attributable to the Congressional Leadership Fund, \$145,907. The Network directly paid wages attributable to the Congressional Leadership Fund of \$61,348. In addition, the shared employees used space and equipment of the Network. The Network estimated that overhead attributable to shared staff working for the Congressional Leadership Fund was \$46,288.
