IN TURN, THE FOOD BANK PROVIDES THE COUNTY DHS WITH QUARTERLY REPORTS ON (A) THE FOOD DISTRIBUTIONS MADE BY THE FOOD BANK TO THE VARIOUS PANTRIES AND (B) THE INFORMATION ON FOOD DISTRIBUTION FROM EACH PANTRY'S QUARTERLY REPORT. THE REPORTS ARE AUDITED ANNUALLY BY THE STATE DEPARTMENT OF AGRICULTURE'S BUREAU OF FOOD DISTRIBUTION. DISTRIBUTION OF NON-GOVERNMENT FOOD DONATIONS THROUGH THE GLEANING PROGRAMS AND THROUGH FOOD DRIVES IS DETERMINED BY THE CHESTER COUNTY FOOD BANK BASED ON NEED AND NUMBERS SERVED.
