THE FOUNDATION OPENED ITS FIRST CHILDCARE FACILITY IN 2011 AND OFFERS FLEXIBLE HOURS DURING THE WEEK FOR CHILDREN SIX WEEKS TO FIVE YEARS OF AGE AND AN AFTER SCHOOL PROGRAM FOR THOSE AGES FIVE TO TWELVE. THE CENTER IS A SECURED FACILITY WITH SAFETY CODED DOORS AND CAMERAS THROUGHOUT THE FACILITY WITH ONLINE ACCESS FOR PARENTS. THE CENTER HAS FULL TIME, PART TIME AND DROP IN SERVICES. THE FOUNDATION FOLLOWS GODLY PRINCIPLES AND STRIVES FOR EXCELLENCE OF CARE FOR THOSE LAW ENFORCEMENT EMPLOYEES WHO SERVE AND PROTECT THE COMMUNITY. DURING THE 2014-2015 FISCAL YEAR, THE CENTER SERVED OVER 150 CHILDREN FROM 17 DIFFERENT LAW ENFORCEMENT AGENCIES, FIREFIGHTERS STATIONS AND MILITARY BRANCHES. WE HAVE KEPT THE FLEXIBLE HOURS THAT THESE EMPLOYEES NEED FOR DIFFERENT SHIFT WORK AND HAVE KEPT THE AFFORDABILITY THAT COMES WITH LONG HOURS. THE CENTER WAS OPEN ALL HOLIDAYS AND SATURDAYS OF THE PAST YEAR.
