K-12 civic engagement program and curriculum development. Nebraskans for Civic Reform (NCR) works with schools to create civic engagement programs that are supplemental to their existing civics curriculum. NCR works with teachers to tie in civic engagement into their existing curriculum. NCR then recruits community leaders to be civic engagement mentors to go into the classrooms and engage students in the community. In addition to civic engagement mentor recruitment and orientation, NCR also recruits local non-profits, governmental organizations, and other entities to help develop and provide interactive and engaging service learning projects for the civic engagement mentors to help implement with the students. In sum, NCR provides the resources for civic engagement curriculum development, recruitment of community leaders, non-profits, and provides coordination of the different elements of the program. Finally, NCR is also working to create the Nebraska Civic Health Partnership in conjunction with the National Conference on Citizenship to increase collaboration and create a unified vision for improving civic engagement across Nebraska among various non-profits, state agencies, and other stakeholders.

Voting rights advocacy, education, and non-profit legal work. NCR actively works in communities in Nebraska to ensure state and federal voting laws are adhered to and upheld in a non-partisan manner. In addition, NCR analyzes and conducts research of potential voting rights legal claims and works to represent individuals whose voting rights were infringed upon. Finally, we meet with Nebraska election administrators across the state to better understand elections and administrative challenges they face in making elections more accessible for all Nebraskans. We issue reports and research that are made available to the public that delve into these issues. All of this research is non-partisan and in most cases, academic in nature.
