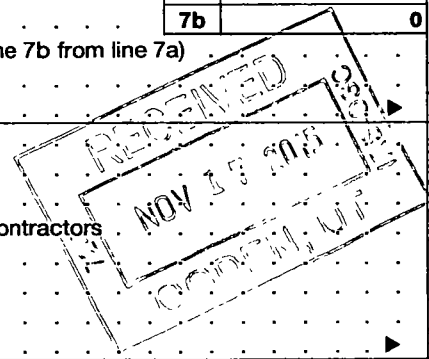

Line 8, Other Revenue: \$276 represents reimbursements from Fairview High School and students for wardrobe purchases we made last year.

Line 10, Grants and similar amounts paid: \$53,880 went to Fairview High School in Boulder, CO. This included grants to pay two department assistants and a choir director (\$29,996), music purchases (\$10,883), professional development (\$5,767), equipment and supply purchases (\$2,417), student activities (\$916), student clinics (\$1,699), and honoraria for department assistance (\$1,610), and scholarships (\$592).

Line 16, Other expenses: \$205 consists of \$54 for bank fees, \$60 for company filing with the state of Colorado, and \$90.21 for office supplies.

Line 26 Total Liabilities: \$5,592 is made up of professional development and professional clinics (\$4,362), professional services, such as concert recording and ticket printing (\$962), and other minor items (\$268).
